The Green Gold Library System Directors met for a regular meeting at the Natchitoches Parish Library, at 10:00 AM on May 21, 2021.

Jennie Weeks and Caleb Sheaffer from Shreve Memorial Library discussed an option for libraries to opt-in to the Public Libraries Connect feature with Overdrive which provides access to age-appropriate ebooks and audiobooks from the local public library in addition to their school's digital collection. As part of the Director's report, Jim Pelton distributed a packet (included) explaining Overdrive, Green Gold's fund balance, fees required for delivery service, and a review of the financial statements for the year ending 9/30/2021.
